## Package Travel - General Terms and Conditions

## 1) Package Travel and Event Information: 2026 4Islands Epic

Travel Destination	4Islands Epic is a four-stage mountain bike race held on the following four Croatian islands in the Adriatic Sea: Krk, Cres, Unije and Lošinj, Croatia.
	Traveler can book the entry for the Event and other services, such as accommodation for her/his team and additional accommodation for a person who is not attending in the mountain bike cycling event (the "Supporter"), as a package travel, choosing from different categories of services as described in this document and detailed during the online registration process. Place of accommodation depends on the selection of the Traveler.
Itinerary and periods of stay	1319.04.2026., 6 nights
Event	The Event is a multi-day mountain bike race held from 1319.04.2026., containing five races (prologue + 4 stages).
	The following schedule of the Event is not confirmed as of today, and the stages and islands hereinafter may be changed or switched by the Organiser.
	Island Krk – Prologue Island Krk- Stage 1 Islands Cres - Stage 2 Island Unije - Stage 3 Island Lošinj - Stage 4
	The confirmed stages will be published as soon as they are available.
Transport	The Organiser is not offering the transport from your place of residence to the country of the Travel Destination. Only the transport between the event locations during the event itself is included in the Package.
	The exact location for departure and arrival for these included transports will be communicated by the Organiser separately.
	The Traveler has the possibility to book additional transport from Zagreb airport to the first stage and from the last stage to Zagreb airport. For this service the traveler needs to pay an extra fee. Those can be booked during the online registration process under "Optional extras".
	The Organiser excludes any liability for transportation services and may not provide any alternative transportation, if the Traveler is not arriving in due time at the respective location for departure. Please inform the Organiser immediately if you ascertain any delay in arriving at the agreed departure location or if you are missing any information with regards to departure time or locations prior to your arrival at the airport or Travel Destination.
Accommodation	Traveller can choose from the following categories of accommodation during the registration process. Detailed description of the accommodation and included services to be found on the website:

	Hotel accommodation: town Baška (island Krk), town of Cres (island Cres), town Mali Lošinj (island Lošinj), all the logistics and transfers between islands are included in the entry package.
	Boat accommodation: all transfers during the race are included in the entry fee, boats are stopping at ferry ports at each island.
	Boat premium accommodation: all transfers during the race are included in the entry fee, boats are stopping at ferry ports at each island.
	The scope of services depends on the accommodation category the traveler chooses and is detailed for each category in the registration process. The standard of each accommodation package is a double/twin room. Upon availability it might be possible to upgrade it to a single occupancy for an extra surcharge.
Meal Plan	Hotel accommodation: breakfast and dinner at the hotel.
	Boat Standard accommodation: breakfast and dinner on the boat. *
	Boat Premium accommodation: breakfast and dinner on the boat. *
	Lunch: at the respective race venue during the race days for everyone with a race entry package.

The respective accommodation service provider will provide you with the information about the services and products included in your bookings upon request.

	1. There is always at least one trader who is liable for the proper
	performance of all the travel services included in the contract.
	2. Travellers may transfer the Package to another person, on reasonable
	notice and possibly subject to additional costs, see the Withdrawal
	Conditions for more information ( <u>link</u> ).

3. The price of the Package may only be increased if specific costs rise (for instance, fuel prices) and if expressly provided for in the contract, and in any event not later than 20 days before the start of the Package. If the price increase exceeds 8 % of the price of the Package, the Traveller may terminate the contract. If the Organiser reserves the right to a price increase, the Traveller has a right to a price reduction if there is a decrease in the relevant costs.
4. Travellers may terminate the contract without paying any termination fee and get a full refund of any payments if any of the essential elements of the Package, other than the price, are changed significantly. If before the start of the Package the trader responsible for the Package cancels the Package, Travellers are entitled to a refund and compensation where appropriate.
5. Travellers may terminate the contract without paying any termination fee before the start of the Package in the event of exceptional circumstances, for instance if there are serious security problems at the destination which are likely to affect the Package.
6. Additionally, Travellers may at any time before the start of the Package terminate the contract in return for an appropriate and justifiable termination fee.
7. If, after the start of the Package, significant elements of the Package cannot be provided as agreed, suitable alternative arrangements will have to be offered to the Traveller at no extra cost. Travellers may terminate the contract without paying any termination fee, where services are not performed in accordance with the contract and this substantially affects the performance of the Package and the Organiser fails to remedy the problem.
8. Travellers are also entitled to a price reduction and/or compensation for damages where the travel services are not performed or are improperly performed.
9. The Organiser has to provide assistance if the Traveller is in difficulty.
10. If the Organiser or, in some Member States, the retailer becomes insolvent, payments will be refunded. If the Organiser or, where

	applicable, the retailer becomes insolvent after the start of the package and if transport is included in the package, repatriation of the Travelers is secured. Organiser has taken out insolvency protection by Generali osiguranje d.d.
